b) Approval of the June 9, 2020 meeting minutes It was motioned/seconded by Wise/Lopez

- c) Stacey Pratt presented the following information regarding the Audited Financial Statements from Fiscal Year 2019/2020:
  - Henderson, Hudson and Company audited the financial statements and related notes for the Modesto-Ceres Fire Protection Agency JPA for the period ending June 30, 2020.
  - The financial statements were found to fairly present the financial position of the Agency and to be in accordance with generally accepted accounting principles.
  - No material deficiencies in internal controls or instances of noncompliance were identified.
  - Total Current Assets \$271,216, an increase of \$3,000 from prior year.
  - Total revenues were \$619,828 which is in an increase of \$4,151, 1%, over the prior year. This increase is primarily due to an increase in tax revenue.
  - Total expenditures, not including distributions to member agencies, were \$11,255.
  - There was no change to fund balance

Resolution 2020-01 accepting the Fiscal Year 2019/2020 Annual Audited Financial Statements for the Modesto-Ceres Fire Protection Agency was motioned/seconded by Ernst/Wise.

- d) Stacey Pratt presented the following information regarding adopting the 2021/2022 Operating Budget:
  - Proposed budget for FY 21-22 is based on FY19/20 Final Actuals plus 8% room for growth. Revenue Growth has been consistent over the past 5 years
  - The budget has previously been calculated based on a 4-year average of actuals, adjusting for any anomalies (such as 1-time revenues, etc.) that is in line with revenue trends.
    - Revenue growth has been consistent over the past 5 years. (FY 17/18 6%, FY 18/19 %10, FY 19/20 %1)
  - Will continue to review both methods for future years to ensure that budget is in line with revenue trends

Resolution 2020-02 accepting the Fiscal Year 2021/2022 Operating Budget for the Modesto-Ceres Fire Protection Agency was motioned/seconded by Ernst/Lopez.

- e) Kevin Wise prompted discussion regarding District Revenues:
  - One option discussed is to increase District Revenues is a possible tax increase, in which residents would have to vote on.
  - Alan Ernst discussed the option of a Cost Recovery Program which can assist in increasing the District Revenue funds.
  - Joe Lopez & Tom Westbrook will schedule a meeting with Stanislaus County to discuss the Cost Recovery Programs and its benefits.
  - Frank Splendorio will review the JPA Agreement to determine the authorization authority of the Board.
  - A follow up meeting will be schedule in February 2021 to discuss the Cost Recovery Program and District Revenues.
